Nil • A person whose age at the time of death exceeded one month but did not exceed 12 years. 25.00 • A person whose age at the time of death exceeded 12 years. 35.00 • For the cremated remains of any child or person in an earthen: <ul style="list-style-type: none"> - Burial grave 9' x 4' – scale of fees for burial apply. 25.00 - Cremated remains grave 4' x 4' 	
3 MONUMENTS, GRAVESTONES AND MONUMENTAL INSCRIPTIONS	
For the right to erect or place on grave category (1a):	
<ul style="list-style-type: none"> • A headstone not exceeding 2' 6" in height 50.00 • A footstone not exceeding 2' in height (sections A, B & C only) 25.00 • Kerbstones or border stones enclosing a space (sections A, B & C only): 35.00 <ul style="list-style-type: none"> - not exceeding 7 feet by 3 feet - enclosing an area in excess of 7 feet by 3 feet, <u>each</u> space of 7 feet by 3 feet 35.00 • A monument in the form of a vase. 25.00 • A monument in any other form. 50.00 • Any additional inscription after the first on a gravestone or monument 10.00 	
For the right to erect or place on grave category 1(b):	
<ul style="list-style-type: none"> • A flat stone tablet not exceeding 1'6" square and 3" in height. 25.00 • Any additional inscription after the first on a flat, tablet stone. 10.00 • No other type of headstone, monument or vase is permitted. 	

In respect of interment of cremated remains into Burial grave category 1(a) providing it is established to the satisfaction of the Clerk that subsequent interments will take place then the fee applied in the first instance of interment shall be that for interment into a cremated remains grave category 1(b) unless interment relates to a stillborn child or person whose age at time of death did not exceed one month, in which case the fee shall be zero.

The foregoing fees, payments and sums will be doubled where the person to be interred or in respect of whom the right is granted is, or was, immediately before death, not an inhabitant or parishioner of Deeping St James, or in the case of a still-born child, neither of the parents is, or was at the time of interment an inhabitant of Deeping St James, unless evidence can be produced to the satisfaction of the Clerk that such person had been a habitant or parishioner during the immediately preceding ten years.
